WHEREAS, the pandemic known as COVID-19 has impacted the economy in the United States, the State of New Jersey and the Township of Maplewood, necessitating a declaration of a State of Emergency in New Jersey and the Township of Maplewood; and

WHEREAS, Governor Phillip Murphy has issued Executive Orders closing and/or modifying certain businesses within the State of New Jersey and the Township of Maplewood; and

WHEREAS, the Governor is beginning to allow businesses to reopen under certain circumstances and conditions; and

WHEREAS, the Township of Maplewood wishes to provide assistance to these businesses as they reopen.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Maplewood, County of Essex, State of New Jersey pursuant to its emergent powers during this State of Emergency that:

1. The following provisions of Chapter 239 of the Code of the Township of Maplewood entitled "Streets and Sidewalks" are modified as indicated;

Article III Obstructions In Streets 239-28Permit required.

A. "Public right-of-way" shall mean, for this section, all dedicated streets, allies or common means of communication, travel or drainage and an area 10 feet from the street curb measured to the adjacent property.

- B. No person shall encumber or obstruct or shall authorize the encumbering or obstructing of any street, highway, alley, public right-of-way (as herein defined), alley or other place in the Township by erecting, depositing, placing or leaving or suffering to be erected, deposited, placed or left therein any building materials, stone, dirt, refuse, ashes, vehicles, structures, obstructions or any articles, materials or things, whatsoever, without first having obtained the written permission of the Township.
- C. Notwithstanding the foregoing, a local retail business may display merchandise and provide services on the sidewalk immediately in front of its retail establishment. A business may only display items and provide services which are sold within the respective business. Such items and services may only be provided on the sidewalk during regular business hours and shall be removed overnight. Fees for such use of the sidewalk shall be waived. A permit shall be valid for up to 120 days and may be renewed. A minimum of four feet of unobstructed paved surface shall be available at all times for pedestrian traffic.
- D Notwithstanding the foregoing, the Township may authorize the creation of parklets, which are temporary converted parking spaces on a street or parking lot into distinctively designed public areas for dining.
- E. Notwithstanding the foregoing, temporary sports equipment may be placed within the grass median strip adjacent to the curb of the resident or homeowner placing the temporary sports equipment on a temporary basis from March 21 to December 31 of each year. Any temporary sports equipment left in the right-of-way, other than as permitted herein, shall be removed, at the owner's expense, by the Township, after a warning notice has been issued of the infraction.
- F. Under no circumstances may the use or positioning of the temporary sports equipment impede the flow of vehicular or pedestrian traffic or emergency Township operations.

All other provisions of Chapter 239 shall remain in effect.

- 1. This Resolution shall take effect upon Governor Murphy's modifying his prior Executive Orders to allow business to operate consistent with the provisions of this Resolution; and
- 2. This Resolution shall terminate on December 31, 2020, at which time all provisions of Chapter 239, as originally adopted, shall be reinstated.

WHEREAS, the Township of Maplewood wishes to provide assistance to these businesses as they reopen.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Maplewood, County of Essex, State of New Jersey pursuant to its emergent powers during this State of Emergency that:

 The following provisions of Chapter 206 of the Code of the Township of Maplewood entitled "Public Property, Use of" are modified as indicated;

Article II. Permit Procedure for Events Held on Township Property 206-4 Definitions.

As used in this article, the following terms shall have the meanings indicated: **EVENTS**

All organized public gatherings, except:

<u>A.</u> Neighborhood block parties, which are governed by Ord. No. 2370-06; <u>B.</u> Filming, which is governed by Chapter <u>125</u> of the Code of the Township

of Maplewood;

C. Unattended outdoor displays, which are governed by Ord. No. 2376-06;

D. Funeral processions by a licensed mortuary; and

<u>E.</u> Demonstrations, protests, picketing or rallies (free-speech activity) that do not involve the use of vehicles, animals, fireworks, pyrotechnics, structures or equipment (other than sound equipment), provided that no fee or donation is charged or required as a condition of participation in or attendance at such free-speech activity, and further provided that the Township Police Administration is notified at least two hours in advance of the commencement of the free-speech activity.

Organized public gatherings shall include market sales sponsored by a Special Improvement District Management Corporation (SID) within its respective district and a local retail service business conducting its business on Township property.

TOWNSHIP PROPERTY

Any and every public street, public building, highway, sidewalk, square, public park or playground or any other public place within the Township of Maplewood ("the Township") which is within the jurisdiction and control of the Township.

206.5 Permit Required

A. No person or organization shall conduct an event on Township property without first having obtained a permit from the office of the Township Clerk, which permit shall set forth the approved location of such event and the approved duration of such event by specific reference to a date or dates, including set-up and break-down. Said permit must be readily available for inspection by Township officials at all times at the site of the event.

B. All permits shall be applied for and obtained from the office of the Township Clerk during normal business hours. Applications for such permits shall be on an approved form and be accompanied by a permit fee in the amount established by this article. Fees are waived for SID market sales. A local retail service business shall pay one fee per permit application regardless of the number of uses requested in that application.

C. A permit shall be valid to conduct events for the period of time specified in the permit. A permit issued for SID market sale shall be valid for up to 120 days and is renewable. A local retail service business may submit one permit application requesting multiple uses of Township property. A permit issued to a local retail service business is renewable.

<u>D.</u> There can be no change in the approved dates and times once a permit has been issued without prior approval by the Township Clerk.

All other provisions of Chapter 206 shall remain in effect.

- 3. This Resolution shall terminate on December 31, 2020, at which time all provisions of Chapter 206, as originally adopted, shall be reinstated.
